The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.19% to settle the year to end return of the market at (-15.90%).

The Index closed at 26,434.00 basis point against the previous close of 26,384.21 basis point while Market Capitalization closed at 12,758,440,092,833.40 against previous close of 12,734,406,955,806.50. Volume traded decreased by 8.18% from 196,291,978 to 180,227,713 while the total value of stocks traded decreased by 14.83% from 3,551,179,241.45 to 3,024,550,238.73 in 2,951 deals compared to 3,153 deals traded previously.

CILEASING, COURTVILLE, OANDO, UBA and UACN top the gainers table by gaining 9.26%, 8.70%, 4.17%, 3.85% and 3.11% while CHELLARAM, UNIONDAC, CHAMS, LINKASSURE and LASACO top the losers table by shedding 9.74%, 8.33%, 8.11%, 5.88% and 3.85%.
