Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.13% to settle the year to end return of the market at (-15.57%).

The Index closed at 26,536.21 basis point against the previous close of 26,569.80 basis point while Market Capitalization closed at 12,807,769,888,723.50 against previous close of 12,823,981,441,065.60. Volume traded decreased by 51.41% from 319,694,315 to 155,346,614 while the total value of stocks traded decreased by 53.40% from 3,072,430,438.21 to 1,431,852,522.78 in 2,773 deals compared to 2,503 deals traded previously.

AGLEVENT, CORNERST, JAIZBANK, ETI and PZ top the gainers table by gaining 8.33%, 6.45%, 6.35%, 5.34% and 5.00% while GLAXOSMITH, LIVESTOCK, OANDO, CAVERTON and ROYALEX top the losers table by shedding 9.48%, 5.88%, 4.74%, 3.92% and 3.70%.
