Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.60% to settle the year to end return of the market at (-15.07%).

The Index closed at 26,695.18 basis point against the previous close of 26,536.21 basis point while Market Capitalization closed at 12,884,498,779,219.30 against previous close of 12,807,769,888,723.50. Volume traded increased by 9.77% from 155,346,614 to 170,523,832 while the total value of stocks traded increased by 43.21% from 1,431,852,522.78 to 2,050,577,603.66 in 2,700 deals compared to 2,773 deals traded previously.

GUINNESS, PZ, AGLEVENT, UBA and ACCESS top the gainers table by gaining 9.83%, 9.52%, 7.69%, 6.06% and 4.26% while CORNERST, NEIMETH, UPL, ROYALEX and FBNH top the losers table by shedding 9.09%, 9.09%, 8.33%, 3.85% and 3.85%.
