

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.22% to settle the year to end return of the market at (-15.60%).

The Index closed at 26,526.35 basis point against the previous close of 26,584.45 basis point while Market Capitalization closed at 12,804,175,763,304.00 against previous close of 12,832,216,475,547.50. Volume traded increased by 12.29% from 304,214,729 to 341,616,127 while the total value of stocks traded decreased by 25.74% from 3,148,506,471.20 to 2,338,236,690.85 in 2,949 deals compared to 2,690 deals traded previously.

NB, UNILEVER, UNITYBNK, FCMB and CUTIX top the gainers table by gaining 9.96%, 9.49%, 7.46%, 5.56% and 3.57% while PZ, GUINNESS, DANGSUGAR, CADBURY and BOCGAS top the losers table by shedding 10.00%, 9.97%, 9.97%, 9.86% and 9.84%.
