Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 1.55% to settle the year to end return of the market at (-16.91%).

The Index closed at 26,115.80 basis point against the previous close of 26,526.35 basis point while Market Capitalization closed at 12,606,824,456,588.90 against previous close of 12,804,175,763,304.00. Volume traded decreased by 44.74% from 341,616,127 to 188,791,402 while the total value of stocks traded increased by 3.96% from 2,338,236,690.85 to 2,430,782,842.32 in 2,605 deals compared to 2,949 deals traded previously.
