

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.73% to settle the year to end return of the market at (-15.34%).

The Index closed at 26,609.34 basis point against the previous close of 26,416.48 basis point while Market Capitalization closed at 12,846,024,588,569.40 against previous close of 12,752,919,605,279.20. Volume traded increased by 72.04% from 222,510,118 to 382,807,044 while the total value of stocks traded increased by 136.39% from 3,040,099,445.07 to 7,186,429,283.41 in 3,212 deals compared to 2,540 deals traded previously.
