

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.38% to settle the year to end return of the market at (0.47%).

The Index closed at 26,968.79 basis point against the previous close of 26,867.79 basis point while Market Capitalization closed at 13,019,552,641,297.70 against previous close of 12,970,797,414,239.50. Volume traded increased by 130.54% from 264,103,517 to 608,859,379 while the total value of stocks traded decreased by 28.10% from 5,231,059,112.25 to 3,761,366,581.29 in 6,071 deals compared to 3,178 deals traded previously.
