The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 3.54% to settle the year to end return of the market at (6.41%).

The Index closed at 28,562.48 basis point against the previous close of 27,586.93 basis point while Market Capitalization closed at 13,787,168,699,742.90 against previous close of 13,316,271,092,537.10. Volume traded increased by 66.18% from 446,383,483 to 741,821,776 while the total value of stocks traded increased by 58.36% from 5,819,623,589.74 to 9,216,119,771.05 in 7,622 deals compared to 5,727 deals traded previously.
