

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.07% to settle the year to end return of the market at (9.59%).

The Index closed at 29,415.39 basis point against the previous close of 29,395.57 basis point while Market Capitalization closed at 15,174,514,920,752.60 against previous close of 15,164,288,304,672.30. Volume traded decreased by 59.47% from 693,188,883 to 280,921,870 while the total value of stocks traded decreased by 35.32% from 7,444,420,298.14 to 4,815,042,659.44 in 5,189 deals compared to 6,634 deals traded previously.
