The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.74% to settle the year to end return of the market at (10.40%).

The Index closed at 29,633.58 basis point against the previous close of 29,415.39 basis point while Market Capitalization closed at 15,287,070,105,829.70 against previous close of 15,174,514,920,752.60. Volume traded increased by 23.96% from 280,921,870 to 348,236,974 while the total value of stocks traded increased by 77.51% from 4,815,042,659.44 to 8,547,142,078.17 in 5,377 deals compared to 5,189 deals traded previously.

MTNN, NPFMCRRFBK, UACN, LASACO and GLAXOSMITH top the gainers table by gaining 10.00%, 9.68%, 7.80%, 7.41% and 6.60% while CADBURY, TRANSCOHOT, NEIMETH, PRESCO and UNILEVER top the losers table by shedding 9.95%, 9.18%, 8.93%, 8.17% and 5.26%.
