Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.75% to settle the year to end return of the market at (8.27%).

The Index closed at 29,062.50 basis point against the previous close of 29,283.15 basis point while Market Capitalization closed at 14,992,466,618,958.10 against previous close of 15,106,294,594,066.80. Volume traded decreased by 46.00% from 666,782,674 to 360,075,638 while the total value of stocks traded decreased by 56.49% from 6,515,781,218.27 to 2,834,858,489.70 in 4,345 deals compared to 5,711 deals traded previously.
