

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 1.00% to settle the year to end return of the market at (9.35%).

The Index closed at 29,352.13 basis point against the previous close of 29,062.50 basis point while Market Capitalization closed at 15,141,881,966,344.70 against previous close of 14,992,466,618,958.10. Volume traded increased by 7.52% from 360,075,638 to 387,164,054 while the total value of stocks traded increased by 77.01% from 2,834,858,489.70 to 5,017,938,308.22 in 4,654 deals compared to 4,345 deals traded previously.
