Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.91% to settle the year to end return of the market at (10.34%).

The Index closed at 29,618.52 basis point against the previous close of 29,352.13 basis point while Market Capitalization closed at 15,256,279,085,743.00 against previous close of 15,141,881,966,344.70. Volume traded decreased by 16.06% from 387,164,054 to 324,974,223 while the total value of stocks traded decreased by 29.16% from 5,017,938,308.22 to 3,554,743,028.53 in 4,175 deals compared to 4,654 deals traded previously.

CORNERST, UACN, ACCESS, COURTVILLE and GUARANTY top the gainers table by gaining 7.41%, 7.00%, 4.35%, 4.35% and 3.55% while GOLDBREW, OMATEK, CHIPLC, UNIONDAC and JAIZBANK top the losers table by shedding 8.99%, 8.89%, 7.69%, 4.76% and 4.41%.
