Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.26% to settle the year to date return of the market at (10.10%).

The Index closed at 29,552.99 basis point against the previous close of 29,628.84 basis point while Market Capitalization closed at 15,222,522,558,604.00 against previous close of 15,261,592,673,395.10. Volume traded increased by 140.59% from 184,558,182 to 444,037,503 while the total value of stocks traded decreased by 4.69% from 3,514,080,340,93 to 3,349,416,391.88 in 4,306 deals compared to 3,852 deals traded previously.

NAHCO, NPFMCRFBK, NEIMETH, LINBKASSURE and VITAFOAM top the gainers table by gaining 9.80%, 9.73%, 8.51%, 8.33% and 6.00% while UNILEVER, ETERNA, ROYALEX, JBERGER and STERLNBANK top the losers table by shedding 9.97%, 9.52%, 9.09%, 6.28% and 5.15%.
