Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 1.08% to settle the year to date return of the market at (6.30%).

The Index closed at 28,533.40 basis point against the previous close of 28,843.53 basis point while Market Capitalization closed at 14,697,338,899,009.50 against previous close of 14,857,086,058,203.30. Volume traded decreased by 27.83% from 348,609,025 to 251,591,615 while the total value of stocks traded decreased by 25.07% from 4,206,987,277.29 to 3,152,356,229.38 in 4,752 deals compared to 4,610 deals traded previously.

LAWUNION, HONYFLOUR, UPDCREIT, LIVESTOCK and UNITYBNK top the gainers table by gaining 10.00%, 9.28%, 8.06%, 3.77% and 1.72% while NCR, FO, CADBURY, STERLNBANK and WAPIC top the losers table by shedding 9.97%, 9.95%, 9.77%, 9.24% and 9.09%.
