Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.17% to settle the year to date return of the market at (4.84%).

The Index closed at 28,140.41 basis point against the previous close of 28,093.76 basis point while Market Capitalization closed at 14,497,294,674,910.70 against previous close of 14,470,885,541,612.70. Volume traded decreased by 9.43% from 350,207,706 to 317,190,513 while the total value of stocks traded decreased by 19.93% from 4,283,368,027.71 to 3,429,662,103.41 in 4,340 deals compared to 4,729 deals traded previously.

LAWUNION, WEMABANK, NAHCO, FCMB and FIDELITYBK top the gainers table by gaining 9.78%, 7.58%, 7.31%, 5.41% and 5.34% while SKYAVN, CILEASING, DAARCOMM, AFRIPRUD and LASACO top the losers table by shedding 9.88%, 9.77%, 8.33%, 5.33% and 3.85%.
