

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 1.05% to settle the year to date return of the market at (3.47%).

The Index closed at 27,772.19 basis point against the previous close of 28,067.09 basis point while Market Capitalization closed at 14,464,434,665,622.06 against previous close of 14,618,025,222,710.80. Volume traded decreased by 34.14% from 303,933,286 to 200,155,486.00 while the total value of stocks traded decreased by 69.89% from 6,385,770,349.61 to 1,922,514,358.94 in 3,487 deals compared to 4,243 deals traded previously.
