

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.36% to settle the year to date return of the market at (3.84%).

The Index closed at 27,871.90 basis point against the previous close of 27,772.19 basis point while Market Capitalization closed at 14,516,363,942,349.72 against previous close of 14,464,434,665,622.06. Volume traded increased by 38.03% from 200,155,486 to 276,268,300 while the total value of stocks traded increased by 92.81% from 1,922,514,358.94 to 3,706,717,854.49 in 3,690 deals compared to 3,487 deals traded previously.
