Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.39% to settle the year to date return of the market at (3.40%).

The Index closed at 27,755.87 basis point against the previous close of 27,864.84 basis point while Market Capitalization closed at 14,455,932,332,518.00 against previous close of 14,512,686,255,567.60. Volume traded decreased by 12.01% from 150,725,160 to 132,624,301 while the total value of stocks traded decreased by 53.99% from 2,781,539,014.08 to 1,279,704,604.82 in 3,189 deals compared to 3,198 deals traded previously.
