The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.67% to settle the year to date return of the market at (2.72%).

The Index closed at 27,570.94 basis point against the previous close of 27,755.87 basis point while Market Capitalization closed at 14,359,617,776,210.30 against previous close of 14,455,932,332,518.00. Volume traded increased by 1.50% from 132,624,301 to 134,612,472 while the total value of stocks traded increased by 23.76% from 1,279,704,604.82 to 1,583,741,596.98 in 3,302 deals compared to 3,189 deals traded previously.

JAIZBANK, JAPAULOIL, OANDO, CORNERST and NPFMCRFBK top the gainers table by gaining 6.25%, 5.00%, 4.35%, 3.70% and 3.60% while LAWUNION, WAPIC, INTBREW, UNITYBNK and ETI top the losers table by shedding 9.57%, 9.09%, 9.03%, 8.77% and 8.57%.
