Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.08% to settle the year to date return of the market at (2.63%).

The Index closed at 27,547.56 basis point against the previous close of 27,570.94 basis point while Market Capitalization closed at 14,347,440,404,754.40 against previous close of 14,359,617,776,210.30. Volume traded increased by 24.86% from 134,612,472 to 168,073,631 while the total value of stocks traded increased by 36.18% from 1,583,741,596.98 to 2,156,791,115.88 in 3,075 deals compared to 3,302 deals traded previously.

WAPIC, UAC-PROP, CILEASING, NEIMETH and JAIZBANK top the gainers table by gaining 10.00%, 10.00%, 7.41%, 6.67% and 4.41% while LAWUNION, JAPAULOIL, COURTVILLE, LINKASSURE and VITAFOAM top the losers table by shedding 4.81%, 4.76%, 4.55%, 4.35% and 3.19%.
