## Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.09% to settle the year to date return of the market at (2.54%).

The Index closed at 27,523.08 basis point against the previous close of 27,547.56 basis point while Market Capitalization closed at 14,338,295,509,844.90 against previous close of 14,347,440,404,754.40. Volume traded increased by 72.64% from 168,073,631 to 290,154,582 while the total value of stocks traded increased by 132.96% from 2,156,791,115.88 to 5,024,508,025.28 in 3,528 deals compared to 3,075 deals traded previously.

UCAP, AFRIPRUD, AIICO, CILEASING and UNITYBNK top the gainers table by gaining 9.90%, 9.87%, 9.76%, 9.48% and 9.26% while MANSARD, FO, CUSTODIAN, NCR and LAWUNION top the losers table by shedding 10.00%, 9.97%, 9.92%, 9.40% and 9.09%.
