## Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.65% to settle the year to date return of the market at (2.04%).

The Index closed at 27,388.62 basis point against the previous close of 27,568.91 basis point while Market Capitalization closed at 14,268,247,277,020.90 against previous close of 14,362,169,103,271.60. Volume traded decreased by 13.14% from 484,991,629 to 421,275,510 while the total value of stocks traded increased by 54.68% from 3,589,589,718.28 to 5,552,493,905.14 in 4,423 deals compared to 4,187 deals traded previously.

JAIZBANK, ROYALEX, LIVESTOCK, UBN and JBERGER top the gainers table by gaining 9.52%, 8.70%, 8.06%, 7.04% and 6.67% while SKYAVN, MAYBAKER, LAWUNION, PRESTIGE and NESTLE top the losers table by shedding 9.97%, 9.90%, 9.88%, 9.84% and 9.02%.
