Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.03% to settle the year to date return of the market at (+0.71%).

The Index closed at 27,033.10 basis point against the previous close of 27,041.03 basis point while Market Capitalization closed at 14,083,037,418,334.00 against previous close of 14,087,168,501,642.20. Volume traded decreased by 43.66% from 429,003,016 to 241,709,999 while the total value of stocks traded decreased by 51.30% from 7,298,075,924.45 to 3,554,427,347.15 in 4,456 deals compared to 4,533 deals traded previously.

LAWUNION, CADBURY, AFRIPRUD, FBNH and ACCESS top the gainers table by gaining 10.00%, 9.76%, 4.29%, 2.83% and 2.27% while SFSREIT, SKYAVN, NPFMCRFBK, AllCO and LINKASSURE top the losers table by shedding 9.94%, 9.75%, 9.68%, 9.38% and 8.89%.
