

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.62% to settle the year to date return of the market at (-0.13%).

The Index closed at 26,808.24 basis point against the previous close of 26,974.38 basis point while Market Capitalization closed at 13,965,894,995,780.20 against previous close of 14,052,449,772,963.50. Volume traded increased by 1.38% from 228,376,852 to 231,528,456 while the total value of stocks traded increased by 63.69% from 2,737,560,762.71 to 4,481,171,355.51 in 3,606 deals compared to 3,831 deals traded previously.
