Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.71% to settle the year to date return of the market at (-15.10%).

The Index closed at 22,789.64 basis point against the previous close of 22,543.07 basis point while Market Capitalization closed at 11,876,247,580,336.00 against previous close of 11,747,753,783,706.60. Volume traded decreased by 0.65% from 675,910,797 to 671,519,295 while the total value of stocks traded increased by 31.26% from 8,059,044,339.31 to 10,578,026,990.48 in 7,247 deals compared to 7,368 deals traded previously.
