Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 3.12% to settle the year to date return of the market at (-17.75%).

The Index closed at 22,078.58 basis point against the previous close of 22,789.64 basis point while Market Capitalization closed at 11,505,700,111,158.40 against previous close of 11,876,247,580,336.00. Volume traded decreased by 21.69% from 671,519,295 to 525,847,823 while the total value of stocks traded decreased by 55.16% from 10,578,026,990.48 to 4,742,806,496.00 in 5,450 deals compared to 7,247 deals traded previously.

AFRIPRUD, JAIZBANK, CORNERST, STERLNBANK and LIVESTOCK top the gainers table by gaining 9.91%, 9.76%, 9.43%, 9.09% and 9.09% while UCAP, ZENITHBANK, ARBICO, FIDSON and PRESTIGE top the losers table by shedding 10.00%, 10.00%, 9.81%, 9.80% and 9.09%.
