Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.13% to settle the year to date return of the market at (-18.94%).

The Index closed at 21,757.47 basis point against the previous close of 21,729.48 basis point while Market Capitalization closed at 11,338,970,696,126.60 against previous close of 11,323,775,081,964.90. Volume traded decreased by 26.26% from 233,474,577 to 172,163,723 while the total value of stocks traded decreased by 15.73% from 2,239,429,176.35 to 1,887,118,121.42 in 3,542 deals compared to 3,874 deals traded previously.
