

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.94% to settle the year to date return of the market at (-21.39%).

The Index closed at 21,100.54 basis point against the previous close of 21,300.47 basis point while Market Capitalization closed at 10,996,610,237,603.30 against previous close of 11,100,803,642,604.60. Volume traded decreased by 63.38% from 422,004,923 to 154,550,658 while the total value of stocks traded increased by 2.52% from 1,724,048,949.19 to 1,767,437,961.87 in 3,415 deals compared to 3,448 deals traded previously.

MTNN, INTBREW, LIVESTOCK, CADBURY and NAHCO top the gainers table by gaining 9.33%, 9.18%, 8.47%, 4.41% and 4.00% while UNILEVER, DANGCEM, GUINNESS, FLOURMILL and ETI top the losers table by shedding 10.00%, 9.95%, 9.92%, 9.88% and 8.99%.
