## Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.13% to settle the year to date return of the market at (-21.41%).

The Index closed at 21,094.62 basis point against the previous close of 21,121.20 basis point while Market Capitalization closed at 10,993,525,508,506.50 against previous close of 11,007,376,330,843.60. Volume traded decreased by 7.94% from 255,592,473 to 235,298,007 while the total value of stocks traded increased by 3.97% from 2,864,535,058.82 to 2,978,129,854.35 in 3,988 deals compared to 4,418 deals traded previously.
