

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 1.47% to settle the year to date return of the market at (-20.33%).

The Index closed at 21,384.03 basis point against the previous close of 21,073.26 basis point while Market Capitalization closed at 11,144,349,999,239.10 against previous close of 10,982,391,535,130.40. Volume traded decreased by 9.09% from 346,409,715 to 314,906,187 while the total value of stocks traded decreased by 3.78% from 5,216,170,916.39 to 5,018,819,178.33 in 5,427 deals compared to 4,660 deals traded previously.

DANGSUGAR, UBA, CADBURY, LASACO and STERLNBANK top the gainers table by gaining 9.74%, 9.73%, 9.52%, 9.52% and 9.45% while OMATEK, CHAMS, UNITYBNK, JAIZBANK and SKYAVN top the losers table by shedding 8.82%, 8.70%, 8.70%, 7.84% and 7.41%.
