

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 2.32% to settle the year to date return of the market at (-18.49%).

The Index closed at 21,879.95 basis point against the previous close of 21,384.03 basis point while Market Capitalization closed at 11,402,801,309,392.50 against previous close of 11,144,349,999,239.10. Volume traded increased by 77.14% from 314,906,187 to 557,819,628 while the total value of stocks traded decreased by 47.85% from 5,018,819,178.33 to 2,617,362,535.76 in 5,310 deals compared to 5,427 deals traded previously.
