

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.07% to settle the year to date return of the market at (-15.97%).

The Index closed at 22,554.84 basis point against the previous close of 22,539.94 basis point while Market Capitalization closed at 11,754,521,304,026.00 against previous close of 11,746,758,226,861.60. Volume traded increased by 16.13% from 326,444,379 to 379,110,193 while the total value of stocks traded increased by 29.60% from 3,338,708,297.07 to 4,327,067,089.55 in 5,985 deals compared to 5,166 deals traded previously.
