## Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.66% to settle the year to date return of the market at (-15.13%).

The Index closed at 22,780.30 basis point against the previous close of 22,629.92 basis point while Market Capitalization closed at 11,872,023,348,665.90 against previous close of 11,793,650,044,691.40. Volume traded decreased by 25.61% from 250,346,066 to 186,229,966 while the total value of stocks traded decreased by 20.32% from 2,325,350,960.72 to 1,852,817,440.87 in 3,446 deals compared to 4,877 deals traded previously.

NEM, WAPCO, LIVESTOCK, TRANSCORP and PZ top the gainers table by gaining 10.00%, 9.66%, 7.69%, 7.35% and 6.25% while SKYAVN, UNIONDAC, GUINNESS and CAVERTON are the only four losers shedding 8.16%, 6.45%, 6.40% and 4.26%.
