## Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.07% to settle the year to date return of the market at (-15.74%).

The Index closed at 22,616.28 basis point against the previous close of 22,599.38 basis point while Market Capitalization closed at 11,786,545,439,460.70 against previous close of 11,777,735,972,972.90. Volume traded decreased by 48.91% from 211,619,815 to 108,120,797 while the total value of stocks traded decreased by 40.35% from 2,234,215,749.41 to 1,332,795,491.55 in 3,354 deals compared to 3,957 deals traded previously.

LASACO, CHAMS, OANDO, GUARANTY and UBN top the gainers table by gaining 8.33%, 4.76%, 3.91%, 3.63% and 3.05% while NB, SKYAVN, TRANSCORP, ROYALEX and AllCO top the losers table by shedding 10.00%, 6.58%, 5.41%, 4.76% and 3.61%.
