Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.49% to settle the year to date return of the market at (-15.33%).

The Index closed at 22,727.87 basis point against the previous close of 22,616.28 basis point while Market Capitalization closed at 11,844,699,329,353.80 against previous close of 11,786,545,439,460.70. Volume traded increased by 146.60% from 108,120,797 to 266,627,724 while the total value of stocks traded increased by 106.56% from 1,332,795,491.55 to 2,752,975,144.05 in 4,259 deals compared to 3,354 deals traded previously.

CORNERST, LASACO, FCMB, GUARANTY and ZENITHBANK top the gainers table by gaining 9.26%, 7.69%, 6.25%, 5.00% and 4.58% while WAPIC, AFRIPRUD, CAVERTON, UNILEVER and INTBREW top the losers table by shedding 7.41%, 5.95%, 4.86%, 4.55% and 4.17%.
