

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.67% to settle the year to date return of the market at (-14.24%).

The Index closed at 23,021.01 basis point against the previous close of 22,868.40 basis point while Market Capitalization closed at 11,997,467,059,477.60 against previous close of 11,917,937,756,337.00. Volume traded increased by 29.57% from 277,429,181 to 359,467,419 while the total value of stocks traded increased by 27.87% from 2,548,202,209.83 to 3,258,305,718.26 in 4,946 deals compared to 4,464 deals traded previously.
