## Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 1.40% to settle the year to date return of the market at (-10.05%).

The Index closed at 24,143.37 basis point against the previous close of 23,809.31 basis point while Market Capitalization closed at 12,582,390,640,381.70 against previous close of 12,408,294,963,554.10. Volume traded increased by 23.60% from 345,175,086 to 426,641,520 while the total value of stocks traded decreased by 3.53% from 4,252,225,354.40 to 4,102,243,110.94 in 7,384 deals compared to 4,689 deals traded previously.

CHIPLC, NB, ARDOVA, CAP and UAC-PROP top the gainers table by gaining 10.00%, 10.00%, 9.84%, 9.57% and 9.52% while CILEASING, UACN, UNIONDAC and INTBREW are the only four losers shedding 6.00%, 3.47%, 3.13% and 2.00%.
