Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 1.27% to settle the year to date return of the market at (-10.42%).

The Index closed at 24,045.40 basis point against the previous close of 24,354.25 basis point while Market Capitalization closed at 12,531,334,100,733.40 against previous close of 12,692,290,764,189.80. Volume traded decreased by 51.67% from 431,582,257 to 208,588,018 while the total value of stocks traded decreased by 58.31% from 5,260,691,930.15 to 2,193,212,108.05 in 4,320 deals compared to 5,860 deals traded previously.

FIDSON, CUSTODIAN, NB, NEIMETH and AFRIPRUD top the gainers table by gaining 7.83%, 7.69%, 7.45%, 6.67% and 5.12% while UAC-PROP, UPL, MTNN, JAPAULOIL and MBENEFIT top the losers table by shedding 8.00%, 7.14%, 6.67%, 4.76% and 4.76%.
