

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.77% to settle the year to date return of the market at (-10.99%).

The Index closed at 23,892.92 basis point against the previous close of 23,709.44 basis point while Market Capitalization closed at 12,441,195,030,065.70 against previous close of 12,356,247,640,864.70. Volume traded increased by 14.76% from 159,235,165 to 182,740,028 while the total value of stocks traded increased by 51.19% from 1,675,336,152.97 to 2,328,660,751.00 in 4,542 deals compared to 3,573 deals traded previously.

FIDSON, NPFMCRFBK, MAYBAKER, FCMB and REGALINS top the gainers table by gaining 9.62%, 9.46%, 5.78%, 5.26% and 5.00% while CUSTODIAN, UNITYBNK, AIICO, NEM and LINKASSURE top the losers table by shedding 9.52%, 8.33%, 7.53%, 7.41% and 6.82%.
