Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.09% to settle the year to date return of the market at (-11.07%).

The Index closed at 23,871.33 basis point against the previous close of 23,892.92 basis point while Market Capitalization closed at 12,440,616,345,863.70 against previous close of 12,441,195,030,065.70. Volume traded increased by 21.18% from 182,740,028 to 221,447,170 while the total value of stocks traded increased by 5.14% from 2,328,660,751.00 to 2,448,298,483.67 in 4,330 deals compared to 4,542 deals traded previously.

STANBIC, NPFMCRFBK, PRESCO, NEIMETH and FIDSON top the gainers table by gaining 9.91%, 9.88%, 9.88%, 9.09% and 8.78% while CILEASING, REGALINS, FCMB, OANDO and VITAFOAM top the losers table by shedding 9.80%, 4.76%, 4.44%, 3.21% and 1.96%.
