Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 1.09% to settle the year to date return of the market at (-9.83%).

The Index closed at 24,202.87 basis point against the previous close of 23,941.75 basis point while Market Capitalization closed at 12,613,400,889,027.70 against previous close of 12,477,313,480,558.60. Volume traded increased by 2.65% from 331,001,743 to 339,756,744 while the total value of stocks traded increased by 33.86% from 2,929,331,578.37 to 3,921,291,338.71 in 4,784 deals compared to 5,544 deals traded previously.

CAVERTON, OKOMUOIL, UNILEVER, CILEASING and CUTIX top the gainers table by gaining 10.00%, 9.99%, 9.85%, 9.78% and 9.56% while LASACO, NAHCO, WAPIC, INTBREW and WEMABANK top the losers table by shedding 8.00%, 4.51%, 3.33%, 3.00% and 1.69%.
