Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.07% to settle the year to date return of the market at (-6.04%).

The Index closed at 25,221.23 basis point against the previous close of 25,204.75 basis point while Market Capitalization closed at 13,144,119,164,300.30 against previous close of 13,135,530,403,884.70. Volume traded increased by 124.06% from 259,575,556 to 581,606,575 while the total value of stocks traded increased by 94.04% from 2,881,109,187.26 to 5,590,619,232.87 in 7,759 deals compared to 5,605 deals traded previously.

NB, STANBIC, MAYBAKER, GLAXOSMITH and ACCESS top the gainers table by gaining 10.00%, 9.98%, 9.96%, 9.79% and 9.70% while ARDOVA, REGALINS, AFROMEDIA, TRANSCORP and WAPIC top the losers table by shedding 10.00%, 8.70%, 7.14%, 6.49% and 6.06%.
