

Dear Esteemed Investor,

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.27% to settle the year to date return of the market at (-5.43%).

The Index closed at 25,383.43 basis point against the previous close of 25,316.15 basis point while Market Capitalization closed at 13,241,496,159,245.10 against previous close of 13,193,597,540,590.20. Volume traded increased by 49.18% from 253,305,908 to 377,882,717 while the total value of stocks traded increased by 128.87% from 2,647,325,671.45 to 6,058,973,036.77 in 4,585 deals compared to 4,775 deals traded previously.
