Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.38% to settle the year to date return of the market at (-5.70%).

The Index closed at 25,312.05 basis point against the previous close of 25,407.96 basis point while Market Capitalization closed at 13,204,261,298,391.70 against previous close of 13,254,296,022,730.80. Volume traded decreased by 23.53% from 353,329,264 to 270,193,043 while the total value of stocks traded decreased by 24.72% from 7,035,663,993.39 to 5,296,157,390.61 in 4,550 deals compared to 4,659 deals traded previously.

UAC-PROP, LINKASSURE, SKYAVN, NEIMETH and CILEASING top the gainers table by gaining 10.00%, 9.76%, 9.69%, 9.52% and 9.28% while CUTIX, LASACO, CUSTODIAN, UNIONDAC and MAYBAKER top the losers table by shedding 9.63%, 7.41%, 7.14%, 6.67% and 5.54%.
