Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 1.15% to settle the year to date return of the market at (-6.79%).

The Index closed at 25,020.72 basis point against the previous close of 25,312.05 basis point while Market Capitalization closed at 13,052,287,844,153.40 against previous close of 13,204,261,298,391.70. Volume traded decreased by 20.61% from 270,193,043 to 214,499,976 while the total value of stocks traded decreased by 52.51% from 5,296,157,390.61 to 2,514,925,230.58 in 4,342 deals compared to 4,550 deals traded previously.

BOCGAS, NEIMETH, LEARNAFRCA, SKYAVN and PRESTIGE top the gainers table by gaining 10.00%, 9.94%, 9.73%, 9.64% and 9.26% while CADBURY, WAPIC, VITAFOAM, CHAMS and BUACEMENT top the losers table by shedding 9.47%, 9.09%, 8.32%, 6.90% and 5.44%.
