Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.34% to settle the year to date return of the market at (-5.61%).

The Index closed at 25,335.09 basis point against the previous close of 25,249.90 basis point while Market Capitalization closed at 13,216,313,176,116.60 against previous close of 13,171,871,117,394.90. Volume traded increased by 16.59% from 230,492,269 to 268,740,447 while the total value of stocks traded decreased by 48.25% from 2,166,451,598.45 to 1,121,080,573.20 in 4,137 deals compared to 4,621 deals traded previously.
