

Dear Esteemed Investor,

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.13% to settle the year to date return of the market at (-6.18%).

The Index closed at 25,182.67 basis point against the previous close of 25,215.04 basis point while Market Capitalization closed at 13,136,806,532,963.90 against previous close of 13,153,691,728,982.60. Volume traded increased by 26.43% from 266,649,776 to 337,129,915 while the total value of stocks traded increased by 6.98% from 3,183,188,592.02 to 3,405,270,895.27 in 3,880 deals compared to 3,978 deals traded previously.

NEIMETH, UNITYBNK, ABCTRANS, JAPAULOIL and AIICO top the gainers table by gaining 9.83%, 9.62%, 8.89%, 8.70% and 6.31% while CAVERTON, PRESTIGE, MBENEFIT, OANDO and JBERGER top the losers table by shedding 10.00%, 9.09%, 8.33%, 7.14% and 6.59%.
