Dear Esteemed Investor.

The Nigerian equity market closed on a negative note today as the All Share Index (ASI) lost 0.09% to settle the year to date return of the market at (-7.12%).

The Index closed at 24,930.88 basis point against the previous close of 24,954.32 basis point while Market Capitalization closed at 13,005,455,465,623.30 against previous close of 13,017,648,445,844.70. Volume traded decreased by 15.68% from 237,652,864 to 200,392,700 while the total value of stocks traded decreased by 1.47% from 1,609,494,943.93 to 1,585,821,488.94 in 4,194 deals compared to 4,808 deals traded previously.

FIDSON, SKYAVN, CAVERTON, HONYFLOUR and REDSTAREX top the gainers table by gaining 10.00%, 8.06%, 7.35%, 6.93% and 4.68% while NEIMETH, PRESTIGE, CILEASING, AIICO and MBENEFIT top the losers table by shedding 9.91%, 9.52%, 9.38%, 9.35% and 8.70%.
