Dear Esteemed Investor.

The Nigerian equity market closed on a positive note today as the All Share Index (ASI) gained 0.17% to settle the year to date return of the market at (-6.96%).

The Index closed at 24,972.89 basis point against the previous close of 24,930.88 basis point while Market Capitalization closed at 13,027,333,981,537.00 against previous close of 13,005,455,465,623.30. Volume traded increased by 32.72% from 200,392,700 to 265,964,169 while the total value of stocks traded increased by 70.81% from 1,585,821,488.94 to 2,708,736,566.85 in 3,564 deals compared to 4,194 deals traded previously.

NESTLE, CADBURY, FLOURMILL, WAPIC and TRANSCORP top the gainers table by gaining 10.00%, 6.67%, 4.35%, 3.03% and 2.78% while SEPLAT, NEIMETH, NPFMCRFBK, MANSARD and AllCO top the losers table by shedding 9.99%, 9.57%, 9.04%, 9.00% and 8.25%.
